SCHEDULE 1
Development restricted
Part 1 of Schedule 2

Class A The enlargement, improvement or other alteration of a dwellinghouse

Class C Any other alteration to the roof of a dwellinghouse

Class D The erection or construction of a porch outside any external door of a dwellinghouse

Class E The provision within the curtilage of a dwellinghouse of any building or enclosure, swimming pool or other pool required for a purpose incidental to the enjoyment of the dwellinghouse as such, or the maintenance, improvement or other alteration of such a building or enclosure.

Class F The provision within the curtilage of a dwellinghouse of a hard surface for any purpose incidental to the enjoyment of the dwellinghouse as such

Class H The installation, alteration or replacement of a satellite antenna on a dwellinghouse or within the curtilage of a dwellinghouse.

Part 2 of Schedule 2

Class A The erection, construction, maintenance, improvement or alteration of a gate, fence, wall or other means of enclosure

Class C The painting of the exterior of any building or work

Part 31 of Schedule 2


Class B Any building operation consisting of the demolition of the whole or any part of any gate, fence wall or other means of enclosure.

The above development rights are removed insofar as the development which would be permitted fronts a highway, open space or waterway.


